- 1. The Port Sheldon Township FOIA Procedures and Guidelines and the Public Summary, attached as Exhibit A, are adopted to be effective July 1, 2015.
- 2. The Township officials are authorized and directed to make the Port Sheldon FOIA Procedures and Guidelines and the Public Summary available to the public at the Township offices and on the Township's website as provided in the Act.
- 3. All resolutions and parts of resolutions are, to the extent of any conflict with this resolution, rescinded, and any existing policy or guidelines regarding FOIA requests are superseded under this Resolution.
